From Third Quarter 2020 until Mid-February 2021

In November 2020, CRCICA's Board of Trustees unanimously voted on the renewal of Dr. Ismail Selim's mandate as Director of CRCICA for a second 4-year term ends in 2024.

### **CRCICA Caseload**

On 15 February 2021, the total number of cases filed before the Cairo Regional Centre for International Commercial Arbitration ("CRCICA") reached 1467 cases, with 25 new cases filed since 1 December 2020.

The cases related to various sectors, including Construction, Tourism & Hospitality, Oil & Gas, Corporate Restructuring, Telecommunications, Media & Entertainment, Civil Aviation, Real Estate Development and Public Procurement.

Parties involved in these cases came from Egypt, Jordan, Lebanon, the UK and the UAE.

The language of the proceedings was Arabic in 22 cases, while English was the language of the proceedings for 3 cases.


Arbitrators appointed during this period hailed from Cameroon, Canada, Egypt, France and Lebanon.

Since 1 December 2020, CRCICA has hosted 19 hearings. Of these 19 hearings, 4 hearings were held with partial in-person attendance and remote attendance, 5 hearings were held via videoconference and the rest of the hearings were held in-person (while respecting the Centre's social distancing measures).

In December 2020, CRCICA was the Winner of the 2020 AfAA Awards in the Categories of Diversity Champion and African Institution of the year.


In December 2020, CRCICA was recognized as one of Africa's 30 Arbitration Power list by the Association of Young Arbitrators (AYA)

# **CRCICA's Contributions to Africa**

CRCICA has been exclusively chosen as the arbitral institution in the Headquarters Agreement between the Confederation of African Football (CAF) and the Government of the Arab Republic of Egypt (ARE). The arbitration clause before CRCICA reflects the core role of CRCICA as the oldest arbitral institution in Africa as well as the privileges of the alternative dispute resolution of sports-related disputes. The Agreement was published in Egypt's Official Gazette on 4 August 2020.









African Institution of the Year

 Within CRCICA's efforts to support ties with Africa, on 18 January 2021, CRCICA hosted at its premises a top delegation of the African Continental Free Trade Area (AfCFTA) headed by H.E. Mr. Wamkele Mene, Secretary General of the AfCFTA as well as representatives of the Egyptian Ministry of Foreign Affairs including the Deputy Director of the African Organizations and Groups.
