

Brief on CRCICA Caseload and Recent Activities in Africa During the Second Half of 2019

On 21 November 2019, the total number of cases filed before the Cairo Regional Centre for International Commercial Arbitration ("CRCICA") reached 1365 cases, with 26 new cases filed since July 2019.


The cases related to various sectors, including Construction, Real Estate Development, Tourism, International Sale of Goods, Hotel Management, Oil & Gas, Pharmaceutical, Telecommunications and Media & Entertainment.



Parties involved in these cases came from Egypt, India, Italy, Kuwait, Lebanon, Saudi Arabia, Sudan, Tunisia and the UK; while appointed arbitrators came from Bahrain, Canada, Egypt, France, the UK and the USA.



The language of the proceedings was Arabic in 19 cases, while English was the language of the proceedings for 7 cases.



During the second half of 2019, CRCICA concluded two cooperation agreements with the Nairobi Centre for International Arbitration (NCIA) in August 2019 and the Lagos

Court of Arbitration (LCA) in September 2019. Both agreements involve, inter alia, promoting and developing arbitration techniques through joint capacity building events, cooperation in the achievement of the goals of the AfAA, and that NCIA and LCA shall be alternative hearing centres of the CRCICA in Kenya and Nigeria respectively and vice versa.
